The results of this survey indicate that the truth is (data) of the above-mentioned regions, are far behind the use of Al and Gen Al when compared to Asia, Europe or USA.



Key Findings



The survey has 239 participants, 39% from CARICOM and 61% from Central America, Dominican Republic and Puerto Rico.

A change of mindset is urgently needed for the region to begin to reap the benefits of AI. Moving from theory to practice is not an option that can be delayed.


- The majority of participants (97%) are interested in exploring Artificial Intelligence (AI) technologies, even though only 63% of participants indicated that AI is very important for the future growth of their organization
- 2. Only 10% of participants are very satisfied with the AI solutions implemented in their organizations, most likely because 70% of participants agreed that they have encountered challenges in integrating AI into existing processes and systems.
- 3. Historically information technology and cybersecurity departments have been the main areas using AI technologies. The results of the Survey, confirm that. The participants indicated that technology (45%) and cybersecurity (34%) are the main areas that benefit from AI. A change of vision is urgent in the region, since AI has shown that it can provide benefits to most areas of organizations.






How interested is your organization in exploring Artificial Intelligence (AI) technologies?





In general terms, how knowledgeable do you consider your organization to be regarding AI technologies?






Only 10% of participants are very knowledgeable about AI technologies

How important do you think AI is to the future growth of your organization??






63% of participants believe that AI is very important to their organization's future growth

- Not Likely at All







How extensively is AI currently being used in your organization?








How satisfied are you with the current Al solutions implemented in your organization?






Only 10% of participants are very satisfied with the AI solutions implemented in their organization

To what extent has Al improved the efficiency of their organization?






15% of participants indicated that AI has significantly improved their organization's efficiency.

We have already invested a significant portion of our budget in Al initiatives.






40% of the participants disagree that they have already invested a significant part of their budget in Al initiatives.


